Complt, a Northbrook Police Officer related in summary that person(s) unknown had placed a posting on Craigslist.org in which his wife's (victim) name and phone number were listed. Complt explained that on 30Dec06 at approximately 1800 hrs, his wife received a call from an unknown person on her residential line. The caller inquired if the party was still on for tomorrow night. The victim inquired to what he was referring to. The caller explained he had seen an ad on Craigslist in which a 23 year old college student was looking to hook up with a few good men. The victim explained that the ad was not true and the caller hung up. The victim had received another call from an unknown person but that person had hung up after she answered the phone.

Complt followed up with Craigslist and discovered the posting (255014601) had been made on 29Dec06 at 1322 hrs. Complt also learned the poster ID address is 67.184.118.125 which originates in the Chicago area and belongs to Comcast Cable Communications, Inc.
